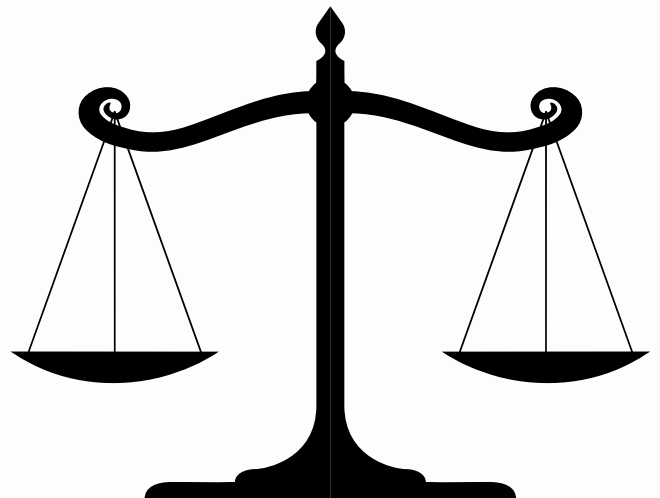

# **FUTURE AUSA PROGRAM**

## **FREQUENTLY ASKED QUESTIONS (FAQS)**

### **1. What is the age range for participants in the program?**

Participants must be between the ages of 13 and 17, currently enrolled in 9th to 12th grade, and have at least one year of high school left after completing the program.

### **2. Are there any location restrictions?**

Yes. Participants must reside within the Eastern District of Pennsylvania. The eligible counties include Berks, Bucks, Chester, Delaware, Lancaster, Lehigh, Northampton, Montgomery, and Philadelphia.

### **3. What does this program cost?**

This program is free to all participants.

### **4. Will transportation be provided?**

No, transportation to and from the program will not be provided. Participants are responsible for their own transportation arrangements.

### **5. Will meals be provided?**

Students will be provided with snacks in the morning and afternoon. However, they are welcome to bring additional food if needed.

### **6. Is prior legal knowledge or experience required to participate?**

No, prior legal knowledge or experience is not required. The program is designed to provide an introductory understanding of the federal legal system and is open to students with a general interest in the field of criminal justice.

## Application for the U.S. Attorney's Future AUSA Program

In a compelling and thoughtful 250-word essay, we invite high school students to embark on a journey of self-reflection and aspiration. Aspiring young minds are encouraged to create a personal statement that sheds light on who they are, their unique qualities, and the reasons why they aspire to be part of the U.S. Attorney's prestigious Future Assistant U.S. Attorney (Future AUSA) Program.

Consider the following aspects while constructing your personal statement:

1. **Begin by introducing yourself** – your name, background, and experiences that have shaped your character. Highlight any notable achievements, community involvement, or academic pursuits that define you.
2. **Share your passion for justice** and the legal system. What motivates you to pursue a career in law? Discuss any personal experiences, observations, or issues in your community that have sparked your interest in making a positive impact through the legal field.
3. Talk about **your connection to the Future AUSA Program**. What aspects of the program align with your aspirations, and how do you envision contributing to its goals?
4. A Federal profession often requires effective **leadership and collaboration**. Share instances from your life where you have demonstrated leadership skills or worked effectively in a team. How do you envision applying these skills within the context of the Future AUSA Program?
5. **Reflect on any challenges you have faced** and how they have shaped your resilience and determination. Discuss how these experiences have prepared you for the responsibilities and demands associated with a career in law.
6. **Summarize** your personal statement by reiterating your passion for law, your connection to the U.S. Attorney's Future AUSA Program, and your commitment to making a meaningful contribution to the legal profession.

*This essay prompt is designed to encourage students to introspect, articulate their aspirations, and demonstrate a genuine interest in the U.S. Attorney's Future AUSA Program. It invites them to weave together their personal narratives with their commitment to justice and the pursuit of a career in law.*

## STUDENT PARTICIPATION CONSENT/RELEASE FORM
